#### **Inception of School of Law at IILM University**

School of Law has been established with IILM University Campus Greater Noida West after COVID19 Pandemic 2022. As libraries are an important part of any academic department, a separate dedicated library has been established for the school of Law at IILM University. The best part to establish this library is that it was proposed, planned and set up in a very short span of time with a good collection in it.

#### Strategy, plan and steps to inception of the library

**Proposal of Library:** Law school has been proposed by the IILM management and got approval for it. After getting approval question was arise to set up new library for the upcoming school of law. Thus library has been proposed and proposal was circulated among the concern authorities as without their consent it was not possible.

**R&D** to establish Law Library: Usually when we think to implement something new in our field, we have to refer the sources, collect the right information, and have to gain knowledge before working on the project.

In the same way when proposal to set up a new law library got approved, some researches were required. Librarian had to visit many law school websites, had to physically visit the law libraries around, had to make discussion with the law librarians to understand the process and to get the contacts to arrange resources. This R & D helped a lot in this new development because it gave way to go further, indicated the scope of improvement to the current working process and increased the efficiency level.

In this process guidance from the experienced and professional focal point was taken on regular basis. DEAN of the School of Law was the key person to guide to develop library structure.

#### Steps involved setting up new library

While setting up new library following process is required and need to understand. "Acquisition, Technical Processing, Reference, Periodicals, Maintenance, and Administration & Finance. Each Section performs specialized library activities" (3). In the context of IILM Law library below steps were taken and considered while establishing the new library.

**Location, Space and structure:** To set up a new library, good location was the concern as any good library requires a good and open space. The law library has been established on to a very vibrant and huge duplex space within the school. The Ground floor of the library building is fully ventilated with huge big windows around.




Fig-1, Law Library, IILM University

**Library Specific Stationary:** While developing the new library structure, some exclusive and specific library stationary is required. It includes Accession Register, Spine Slips, Due Date Slips, library Stamps. Generally, it takes some time to arrange these things for the library. In this case, as library inspection was due and had very short time to set up the library, all things were arranged very quickly with the help of management, support staff and the library colleagues.

Official documents made readily available, separate files including books procurement and bill file, database and journal subscription files, infrastructure development purchase files were prepared for future reference.

#### **Information resources**

Generally, the users come to the library to gather and collect the accurate information of their needs. Therefore every library has to keep various services to cater their users with the right information at the right time. Library has to provide relevant information materials to their users in a managed way. Thus to keep different kind of resources including physical and digital resources is the obligation for the library. Especially in the special libraries it is very important of have specialized type of resources to its users.

**Resources:** To develop a good library good resources are very important. For the law library, resources were selected with the help of the DEAN of Law School. On the very urgent basis books were shortlisted; quotations were asked from the vendors and after comparison of the cost from various vendors, books were procured from 3 vendors. At the ground floor of the library, the Reference section, Periodical section, Book section, and fiction section is available there. AIR Manuals since 2012 to till date made available in the library. Supreme Court Cases were kept in the reference section of the library since 2015. Many hard copy journals were subscribed in the library including Journal of Indian Institute of Law.

**Processing and shelving of resources:** No library can be maintained by collecting and procuring books and resources only. It needed proper processing and shelving to make them usable and accessible. On a routine or regular basis this takes time from the procurement to shelving but here in this library as mentioned due to lack of time all 700+ books were processed including accessioning, stamping, classified, cataloged within 3-4 days and shelved properly in the designated sections and racks, spine slips with the complete ascension number and call number has been put on each and every book.

Periodical section made separately and tagged with the proper title on the top of the section and the periodical register has been maintained.

**E-Resources:** Nowadays to grow and expand the level of information and fast influence of the internet and development of the different sources of information and knowledge, rapid transformation of media tools have extended the role of librarians. no library is completed without having e-resources and digital knowledge portals in it. To give a smart look to a library it is important to have a digital environment within it. Here at IILM, the law library is fully equipped with computers connected with good speed wi-fi. E database Manupatra, DELNET database has been subscribed for the law students. KOHA automation database is available for students.

At present, the Internet is the most comprehensive and up-to-date source of information and its popularity is still increasing. Accordingly, in view of the main mission of libraries to address the information needs of users, today new models for library design are considered, among which digital libraries have a special place in the virtual environment of the Internet.(4)




Fig-3, Koha database




Fig-4, KOHA-OPAC




Fig-5, Manupatra Database

At the entry gate of the library, notice board has been placed to display the new and upcoming information about the library services and activities.




Fig-6, Notice Board
